**ORDER**

**THIS MOTION**, made by the plaintiff, for an interlocutory injunction pursuant to section 101 of the *Courts of Justice Act* and Rule 40.01 of the *Rules of Civil Procedure*, was heard at Milton on March 25, 2022 by video conference.

**ON READING** the Affidavits contained within the Motion Record of the Plaintiff, the Supplemental Motion Records of the Plaintiff, and the Motion Record of the Intervenor, filed; and on hearing the submissions of the lawyer(s) for the Plaintiff and the Intervenor, with no one attending for the Defendants, who were duly served as appears from the Affidavits of Service dated March 23, 2022 and March 24, 2022, filed, and with the Plaintiff and the Intervenor giving the appropriate undertakings for damages:

1. **THIS COURT ORDERS** that the time for service, filing and confirmation of the Plaintiffs' Notice of Motion, Motion Record, Supplemental Motion Record, Factum, and Book of Authorities is hereby abridged so that this Motion is properly returnable today.
  
2. **THIS COURT ORDERS** that the Defendants and any persons having notice of this Order shall be and are hereby restrained and enjoined from, directly or indirectly, by any means and alone or with the assistance of or in combination with any other persons:
  - (a) blocking, preventing or interfering with vehicular or pedestrian access to or egress from any of the facilities whose names and locations are listed in **Schedule "A"** to this Order (the "**Named Facilities**");
  
  - (b) encouraging, inducing or importuning any other person to block, prevent or interfere with vehicular or pedestrian access to or egress from any of the Named Facilities;


- (c) threatening, harassing or intimidating any other persons for the purpose of inducing them not to enter or leave any of the Named Facilities;
  - (d) causing, or inducing or encouraging others to cause, physical damage to trucks and other property of the owners, occupiers, and/or operators of the Named Facilities, or of any persons who wish to do business with the owners, occupiers, and/or operators of the Named Facilities, or to enter or leave any of the Named Facilities.
- 3. **THIS COURT ORDERS** that any police officer with any municipal Police Service, or the Ontario Provincial Police, and any other police authority (the “Police”) shall have authorization to arrest and remove any person who has knowledge of this Order and who the Police have reasonable and probable grounds to believe is contravening or has contravened any provision of this Order.
- 4. **THIS COURT ORDERS** that the Police or designated agents shall have authorization to remove any vehicles, personal property, equipment, structures, or other objects that impede or block access to the Named Facilities and approaching roadways.
- 5. **THIS COURT ORDERS** that the Police shall retain discretion:
  - (a) as to the timing and manner of enforcement of this Order, and specifically retain discretion as to the timing and manner of arrest and removal of any person pursuant to this Order;

- (b) to detain and release any person without arrest who the Police have reasonable and probable grounds to believe is contravening, or has contravened, any provision of this Order, upon that person agreeing to abide by this Order; and
  - (c) and to lay any charges or take any other lawful action.
- 6. **THIS COURT ORDERS** that any peace officer and any member of the Police who arrests or arrests and removes any person pursuant to this Order shall have authorization to release that person from arrest upon that person agreeing in writing to obey this Order.
- 7. **THIS COURT ORDERS** that the terms of this Order bind the Defendants and every other person or legal entity who is subject to this Order and is given notice of this Order, as of the time such Defendants, person or legal entity first receives notice of the Order, and whether or not such respondents, person or legal entity has been served with a copy of the Order.
- 8. **THIS COURT ORDERS** that the terms of this Order shall remain in force until varied or discharged by a further Order of the Court.
- 9. **THIS COURT ORDERS** that notice of this Order shall be given by the creation of a URL whereby this Order can be viewed and downloaded, with the Plaintiff and the Intervenor posting the URL linking to the Order on their websites, being:
